

RULES OF ACCOMMODATION IN HOSTELS

EKIBASTUZ ENGINEERING AND TECHNICAL INSTITUTE NAMED AFTER ACADEMICIAN K. SATPAYEV

1 General provisions

1.1 These Rules of accommodation in the hostel of Ekibastuz Institute of Engineering and Technology named after V. I. Abramovich. akad. K. Satpayev (EITI) is a regulatory act, the implementation of which is mandatory for all residents of the student dormitory.

1.2 The provision of places in the hostel to all students in need is not guaranteed. Places in student dormitories are provided for nonresident EITI students. Nonresident students are allowed to move in according to an application signed by the supervising head of the Department of Internal Affairs and the Dean of the faculty. Check-in is carried out on the basis of a signed agreement for the provision of a room.

1.3. Check -in to the student hostel starts on 25August 25.

1.4. When moving into a hostel, a student and EITI are held on the basis of a signed agreement for the provision of a room.

1.5. A person moving into a hostel must study these Rules, pass a safety briefing conducted by the head of the household, and sign the Register of Persons who are familiar with the Rules of Living in student dormitories and with the Safety Regulations.

2 Rights and obligations of people living in the hostel

2.1 Residents of the hostel have the right to:

- use the dorm rooms, equipment , and inventory .
- participate through the Student Council in solving issues related to improving housing and living conditions, organizing leisure activities, decorating and equipping residential premises, recreation rooms and independent work of students.

2.2 Residents of the hostel must:

- comply with the Charter, Regulations on Student Dormitories, these Rules, Safety Regulations, and the Lease Agreement for residential premises;
- comply with the requirements of the legislation on migration of citizens, the rules of registration of citizens at the place of temporary stay and permanent residence;
- take care of the premises, equipment and inventory of the hostel, bear material responsibility for the property transferred to it for personal use in accordance with the legislation of the Republic of Kazakhstan;
- reimburse the cost of lost or damaged inventory and equipment, or compensate for other damage caused by EITI;
- participate in performing cosmetic repairs of residential premises and common areas on their own and at their own expense;
- at the end of the school year, hand over the living room in safety to the head of the household (walls, doors, locks, furniture must be repaired by residents in case of their breakdown);
- allow an EITI representative to enter the residential premises to inspect the technical condition of the residential premises, sanitary and other equipment located in it, as well as to perform necessary work;
- if malfunctions of the residential premises, equipment or communications located in it are detected, immediately take possible measures to eliminate them and report them to the commandant of the hostel without fail;
- maintain proper sanitary condition of residential premises, carry out wet cleaning in residential and public areas, office premises and living rooms according to the established schedule;

- observe sanitary rules and regulations, including changing bed linen (duvet cover, sheets, pillowcase) as it gets dirty, but at least once a week; observe personal hygiene rules;
- экономно расходовать use electricity and water sparingly.
- strictly follow the instructions for using approved household electrical appliances.
- observe silence in the hostel from 23.00 hours to 7.00 hours;
- according to the Lease Agreement for residential premises, when evicting (including during the holidays), rent out rooms and all bedding listed for them.

2.3 Residents of the hostel are not allowed to:

- drink alcoholic beverages, appear in the hostel in a state of alcoholic, narcotic or other toxic intoxication;
- use, store, or distribute narcotic drugs or psychotropic substances;
- smoking in residential areas and public areas (including hookahs);
- bring в alcoholic beverages to the hostel.
- bring weapons, including pneumatic, traumatic and cold weapons, into the territory, store them, and use them in residential premises and on the territory of the hostel.
- hold meetings of a religious nature, events prohibited by the Law "On Freedom of Religion and Religious Associations";
- самовольно move in and move from one room to another without permission.
- самовольно move inventory from one room to another without permission.
- make alterations and repairs to electrical wiring.
- install additional electric heating devices in living rooms and common areas;
- turn on radios, tape recorders, mobile phones, and televisions with a volume that exceeds the audibility within the room.
- arbitrarily insert locks in the doors of living rooms or replace existing locks in the doors;
- unauthorized dismantling of furniture and erecting partitions;
- keep animals in student dormitories.
- organize dances, discos, and other mass events without permission.
- leave garbage в в rooms and common areas.
- throw garbage and other objects out of the windows, pour water out of the windows, shake dust from carpets and blankets through the windows; store food outside the windows;
- bring в общежитие guests to the hostel from 22.00 to 16.00 hours;
- come to the hostel later than 23.00 hours.

3. Liability for violation of these Rules

3.1 For violation of these Rules, those residing in accordance with the procedure established by EITI may be subject to public and administrative measures, disciplinary and other types of penalties in accordance with the legislation of the Republic of Kazakhstan and regulatory acts of EITI.

3.2 For violation of these Rules by residents, the following disciplinary penalties are applied to them: remark, reprimand, eviction from the hostel with the termination of the concluded Contract.

3.3 A disciplinary penalty is applied immediately upon detection of a misdemeanor, but not later than one week from the date of its detection (not counting the time of illness or when the student is on vacation).

4. Grounds for eviction from the hostel

4.1 Residents may be evicted from the EITI hostel in the following cases:

- use of residential premises не for other purposes;
- destruction or damage to residential premises and equipment by residents or other citizens for whose actions they are responsible (damage to windows, doors, walls, floor, ceiling, locks, sockets, electrical wiring, electric stoves, refrigerators, washing machines, water taps, batteries, mosquito nets, etc.)
- appearance in the hostel in a state of alcohol or drug intoxication, systematic smoking in rooms, corridors and other premises of the hostel, as well as the adjacent territory;
- use, storage, or distribution of narcotic drugs or psychotropic substances;
- storage of explosives, chemically dangerous substances, firearms, traumatic weapons, and cold weapons by residents of the hostel;
- violation of the rights and legitimate interests of neighbors by residents, which makes it impossible to live together;
- expulsions of students from EITI before the end of the training period due to violations of these Rules, the Charter and Internal Regulations;
- at the personal request of residents;
- when отчисления a student is expelled from EITI at the end of the term of study;
- in other cases stipulated by the legislation of the Republic of Kazakhstan and EITI regulations.

4.2 A student who is evicted for gross violation of the Rules of accommodation in EITI dormitories is deprived of the opportunity to re-settle in the hostel.

4.3 Students who do not rent a room in good condition to the head of the household at the end of the school year are deprived of the opportunity to re-settle in the hostel.

4.4 Eviction from the EITI hostel as a disciplinary measure is issued by the rector's order.

4.5 Eviction of residents from the EITI hostel is carried out within three days from the date of issuing the order.
