## 1 Scope of application

This Regulation on the provision of educational discounts (benefits) for tuition fees to students studying at the Institution «Ekibastuz Engineering and Technical Institute named after Academician K. Satpaeva» (hereinafter referred to as the Institute) on a contractual basis (hereinafter referred to as the Regulation) regulates the procedure for granting discounts and other benefits for tuition fees to full—time students.

## 2 Regulatory references

References to the following regulatory documents are used in this Regulation:

- Law of the Republic of Kazakhstan dated July 27, 2007 No. 319-III «On Education»;
- Internal regulatory documents of the Institute;
- The Charter of the Ekibastuz Engineering and Technical Institute named after academician K.Satpayev.

## 3 Basic concepts and definitions

*Discount* is a reduction in the cost of paid educational services for a certain period according to this Provision, provided that the student fulfills certain conditions necessary to receive a discount (benefits), i.e. necessary to change the price of educational services by reducing;

*The discount period* is the period of time for which the student has the right to pay a reduced part of the cost of paid educational services (semester, academic year);

*The benefit* is provided to students in the form of an increase in the payment period for tuition (not in two tranches, but monthly).

## 4 General provisions

4.1 The present Regulation on the provision of discounts (benefits) for tuition fees to students studying at the Ekibastuz Engineering and Technical Institute named after Academician K. Satpayeva (hereinafter referred to as EITI) regulates on a contractual basis (hereinafter referred to as the Regulation) the procedure for granting discounts and other benefits for tuition fees to full—time students.

The regulation was developed for the purpose of social support for students, as part of the Institute's mission to train competent and competitive specialists for the region and the country, which determined the cost of tuition below the state grant, taking into account market conditions, based on data on the solvency of the population.

4.2 A discount in the EITI is the amount by which the price for educational services is reduced for a certain period according to this Regulation, provided that the

student fulfills certain conditions necessary to receive a discount (benefit), i.e. necessary to change the price of educational services by reducing.

4.3 The benefit is provided to students in the form of an increase in the payment period for tuition (not in two tranches, but monthly).

## **5 The procedure for granting discounts (benefits) on tuition fees**

5.1 Discounts (benefits) are provided to students by the Vice-president of the EITI named after Academician K. Satpayev on the basis of an application for a period of one academic year.

5.2 Applications for discounts (benefits) and supporting documents are submitted during the period of work of the admission committee for applicants to the first year.

5.3 Establish a system of discounts for educational services of higher education according to the contractual form of study, taking into account that one student has a discount (benefit) on one of the following points.

Applicants, prize-winners of the subject Olympiads and the Republican competition of scientific projects	20	Diploma / certificate
Children from families with four or more minor children(up to 24 years old)	10	Birth certificates of all children; identity documents of parents; certificate of family composition

Children from low-income families, one parent or both parents are disabled, both parents are retired (up to 24 years old)	10	A photocopy of the student's or student's birth certificate, a death certificate of one of the parents or a certificate from the registry office about the father's record from the mother's words, a decision to deprive one of the parents of parental rights, a medical and social expert opinion
When several family members study at the institute at the same time	10 (each)	Certificate of family composition, certificate from the dean's office
Applicants from single-parent families (up to 24 years old)	10	Birth certificates, divorce/death certificate of one of the parents.
Applicants left without parental care (up to 24 years old)	50	A copy of the student's or student's identity card, the death certificate of the parents, the decision on guardianship, the decision on the deprivation of parental rights
Persons with disabilities, persons with disabilities of groups 1, 2	10	Medical and social expert opinion
Graduates of the EITI named after ak. K. Satpayev and the EKITI named after ak. K. Satpayev, enrolled in shortened terms of study	10	Diploma of the EITI named after Academician K. Satpayev, EKITI named after academician K. Satpayev

5.4 A discount on payment for educational services is not provided if the applicant does not have the grounds provided for in this Regulation, as well as in case of violation of the terms of payment for educational services established by the agreement.
