1 Scope of application

- 1. This Regulation defines the procedure and types of educational grants provided by Marat Pazylovich Mardenov, the founder of the Institute, for applicants with a UNT certificate. The grant is awarded to students studying at the paid department in accordance with the admission rules of the Ekibastuz Engineering and Technical Institute named after Academician K. Satpayev.
- 2. The Regulation is valid in the University "Ekibastuz Engineering and Technical Institute named after Academician K. Satpayev" from the moment of approval.

2 Normative references

This documented procedure uses references to the following regulatory documents:

- Law of the Republic of Kazakhstan dated July 27, 2007 "On Education";
- Standard rules for admission to study in educational organizations that implement educational programs of higher education. Order of the Minister of Education and Science of the Republic of Kazakhstan No. 600 dated October 31, 2018;
- Charter of Ekibastuz Engineering and Technical Institute named after Academician K.
 Satpayev.

3 Terms. Definitions

Candidate - a person entering the Institute applying for an educational grant from the founder of the Institute, Marat Pazylovich Mardenov.

4 General provisions

- 4.1 The grant of Founder M. P. Mardenov of the Ekibastuz Engineering and Technical Institute named after Academician K. Satpayev (hereinafter referred to as the Grant) is established in accordance with the Regulations on Granting Benefits to Students.
- 4.2 This Regulation is valid for applicants of the corresponding year of admission and is aimed at:
- implementation of a system of social protection measures for various categories of students. Ekibastuz Engineering and Technical Institute named after Academician K. Satpayev (hereinafter-EITI);
 - 4.3 Grant-the target amount of funds from the EITI budget to pay for training in the chosen

educational program in the amount established by the curriculum and programs of academic disciplines. The grant does not cover the costs of additional and re-studied subjects and the elimination of differences in academic disciplines. The Grant period is 1 year.

- 4.4 Citizens of Kazakhstan who have certificates of unified national testing (hereinafter referred to as UNT) with scores of at least the threshold score established by the Standard Admission Rules and who have entered the EITI for full time education on a paid basis can apply for the Grant.
 - 4.5 The total amount of the Grant is distributed as follows:
- applicants from socially vulnerable segments of the population/ who scored the maximum score according to the UNT results.

5 Grant award procedure

- 5.1 Applicants from socially vulnerable segments of the population
- 5.2 Applicants belonging to the following categories of citizens are allowed to participate in the Grant competition:
 - orphaned children;
- children with disabilities of group I or 11; children who have one or both parents with disabilities of group I and/or II; if there are other disabled children of group I or II in the student's family;
 - children from large families (four or more children under the age of 18);
- children from low-income families with a difficult financial situation (if there are supporting documents).
- children from single-parent families (if there is a death certificate of one of the parents, a single mother);
 - 5.3 When conducting a competition, priorities are set in the order indicated above.
- 5.4 In the case of the same indicators of these categories of citizens, Grants are awarded to persons with higher UNT certificate scores.
- 5.5 Candidates submit an application to the admissions committee during its work period with the following documents attached:

6 Procedure for applying for the grant of Marat Pazylovich Mardenov, founder of the Institute

- a candidate applying for a grant must submit a written application to the rector with all the necessary documents attached to the Institute's admissions committee.
- documents submitted in a foreign language must have a notarized translation into Kazakh or Russian.
 - applications are accepted until August 20, 2025.
 - the technical secretary of the admissions committee keeps a log of student applications.
 - the commission considers all applications from August 22, 2025 to August 25, 2025.
 - The Commission's decision is recorded in minutes.
- by signing the application, the Candidate guarantees that the information provided to them is reliable.

7 A student loses the Grant in the following cases:

- when you drop out of the institute;
- if there is an academic debt based on the results of the exam session.
- for violation of the Charter and internal regulations of the Institute;
- when switching to a state educational grant;
- in case of receiving an unsatisfactory grade in at least one subject based on the results of the examination session, the Grant holder is deprived of the Grant upon the corresponding submission of the Dean of the faculty
 - 7.1 When granting academic leave, students retain the right to study on the basis of a Grant.
- 7.2 The educational grant is cancelled by the Rector's order based on the decision of the Academic Council of the Institute.
- 7.3 In case of refusal of the Grant holder, the released Grant is awarded on a competitive basis among the remaining applicants in accordance with the procedure established by these Regulations.
